

TERMS AND CONDITIONS

- 1. The participant must be at least 18 years old.
- 2. The participant must be physically and mentally healthy. Any health and mental conditions have to be mentioned before applying or INSPIREnepal has the right to refuse or send back the participant.
- 3. INSPIREnepal has the right to refuse a placement or offer another placement in agreement with the participant. The confirmation of registration will be sent only if the participant and INSPIREnepal foundation have an agreement.
- 4.1 The participant is responsible for accuracy, completeness and reliability of the data and information provided to INSPIREnepal by him. INSPIREnepal will only get started if all the data is provided by the participant.
- 4.2 If before or during the stay of the participant in Nepal shows that the information provided by the participant INSPIREnepal incorrect, incomplete or unreliable, INSPIREnepal is entitled to terminate the participation of the participant. In that case, the participant is not entitled to compensation or reimbursement of costs incurred and paid.
- 5.1 The participant must be in possession of a valid passport.
- 5.2 INSPIREnepal can assist in applying for a visa. Application and obtaining any necessary visas remain the responsibility of the participant.
- 5.3 If the issuance of a visa is denied or if the vis is not requested in time, the participant is not entitled to a refund of the program fee.
- 6.1 After confirmation of registration, the participant must pay a deposit for participation as stated in the confirmation within 14 days.
- 6.2 The remaining balance of the payment must be paid 30 days before the departure date.
- 6.3 Cancellation of the program, the participant will get back a portion of the down payment if the participant passes the cancellation on time, at least 30 days before departure date. If the participant already arrived at their project, no refund will be given.
- 6.4 30 days before the departure date, the participant has no right to a refund if canceled since INSPIREnepal will have to arrange a host family and we want to maintain a good relationship with the hostfamilies.

TERMS AND CONDITIONS

- 7.1 INSPIREnepal informs the participant about the rules, standards and guidelines that apply to participate in the project. If the participant fails to comply with these rules, standards and / or guidelines, INSPIREnepal is entitled to terminate the participation of the participant or to take measure according the situation. In that case, the participant is not entitled to reimbursement of costs incurred and paid.
- 7.2 During your stay you are representing INSPIREnepal. Your assignments or videos that within agreement of INSPIREnepal are allowed to be used, should be referred as of INSPIREnepal.
- 7.3 Photo's and videos taken during your stay with INSPIREnepal of your projects, are a part of INSPIREnepal.
- 7.4 Any information that you gathered on your project during your stay with INSPIREnepal that will be used other than for INSPIREnepal, needs confirmation from INSPIREnepal to be used.
- 7.5 INSPIREnepal will conduct its advice and / or guidance of the participant to the best of its ability and with professional care. However INSPIREnepal cannot guarantee the achievement of any intended results.
- 7. 6 The rules, standards and guidelines referred to in 7 paragraph may be given in writing or verbally and can be added during your stay according to situations and behavior.
- 8.1 INSPIREnepal cannot be held liable in case of illness, theft or other cases. The participant must travel cancellation insurance to exit and take responsibility.
- 8.2 In case of damage incurred by the participant, the participant must pay damages. This applies to damage to the host family, the volunteers place or the office of INSPIREnepal.
- 9.1 If INSPIREnepal force majeure, is prevented from fulfilling the agreement, INSPIREnepal is entitled to implement the agreement to suspend. The participant in that case have no right to compensation for damages, costs or interest.
- 9.2 If a force majeure will include: war, threat of war, natural disasters, strikes, fire, accident or illness of personnel, operational failure, interfering statutory provisions and any other circumstance not only the will of INSPIREnepal depends.
- 10.1 By applying for your stay with INSPIREnepal and having paid for your project, you are accepting the conditions of INSPIREnepal and actions can be taken when the conditions are not followed by the participant.
